

# Wrist Recycling Certificate

## Material Declaration In accordance with IMO Resolution MEPC.269(68) guidelines

In accordance with Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships 2009, Resolution MEPC.269(68) (IHM-Guidelines) of IMO and EU Regulation 1257/2013 of the European Parliament on safe and environmentally sound ship recycling (together the Regulations), WRIST-KLEVENERG SHIP SUPPLY ROTTERDAM hereby confirms that items supplied under sales order rot-0043180 and customer reference LifeBuoy SI Light (EX TYPE) to the best of our knowledge do not contain concentrations of the substances higher than their respective threshold values as provided in the Regulations unless otherwise mentioned in this document.

### Substances being monitored (as per the Regulations):

- Asbestos
- Polychlorinated Biphenyls (PCBs)
- Ozone Depleting Substances
- Antifouling compounds, systems & paints containing organotin compounds
- Cadmium and Cadmium Compounds
- Hexavalent Chromium and Hexavalent Chromium Compounds
- Lead and Lead Compounds
- Mercury and Mercury Compounds
- Polybrominated Biphenyl (PBBs)
- Polybrominated Diphenyl Ethers (PBDEs)
- Polychlorinated Naphthalenes (more than 3 chlorine atoms)

- Certain Shortchain Chlorinated Paraffins (Alkanes, C10-C13, chloro)
- Brominated Flame Retardant (HBCDD)
- Perfluorooctane Sulfonic acid (PFOS) (regarding vessels flying a flag of an EU country)

### Scope of IHM and related MD-documentation

According to §2.2 of IMO Resolution MEPC.269(68) the inventory of hazardous materials only needs to consider items that are fixed to the vessel (welded, bolted, riveted or cemented). According to §3.3.1 steel & alloys (steel, aluminum, brasses, bronzes, plating and solders) are excluded. Household items like appliances (e.g. computers, refrigerators, printers, scanners, televisions, consumer batteries, fluorescent lamps & bulbs, furniture) are not to be considered in the part of the inventory log containing hazardous materials. These items are therefore not part of Material Declarations
